A professional independent practitioner, fully accountable and responsible for their own clinical nursing practice, working within a multi-disciplinary team, works with individuals across the lifespan with a concentrated focus on youth in the areas of sexual and reproductive health, STBBI's and mental health.

The Nurse Practitioner – St. Vital reports directly to the Program Manager and is accountable to the communities we serve.

KEY RESPONSIBILITIES

Focused Health Assessments:

- Assess, diagnose and manage clients' health and concerns based on their experiences and the social determinants of health.
- Determine and prescribe treatments and interventions based on clinical experience which help the people we serve incorporate treatment plans into their daily lives.
- Apply principles of pharmacology in selecting and prescribing drugs. Monitor and discuss with people served, expected drug treatment response and adherence and make adjustments to achieve desired outcomes.
- Provide intermediary medical care and interventions for persons who may be systemically marginalized and face barriers to accessing quality and effective primary health care services.

Collaborative Case Management:

- Maintains accurate, current and concise written records including education and evaluation for each community member as per documentation and charting policies.
- Consistently evaluates community member health/wellbeing goals, progress and outcomes and resets as necessary and in conjunction with the multidisciplinary team
- Provides effective written/verbal communication to the community members' Health Care team and to involve other prescribers as required.

Clinical Nursing:

- Practice from person-centered, harm reduction, social justice and Trauma informed/healing centered approaches that address the whole person (physical, spiritual, mental/emotional)
- Applies evidence-based and innovative knowledge of sexual and reproductive health, STBBI's and mental health to direct care.
- Demonstrated experience working with youth and young adults and with sexual/reproductive health and STBBI prevention and treatment management including health coaching and case management skills.

Advocacy:

- Support community members who may be unable to advocate for themselves.
- Advocate for process/policy change to promote safety, equity, access, person-centered, trauma informed and harm reduction approaches.
- Advocate for the use of Indigenous health knowledge and healing practices in collaboration with Indigenous healers and Elders consistent with the Calls to Action of the Truth and Reconciliation Commission of Canada.

QUALIFICATIONS

- Eligible for registration with the College of Registered Nurses of Manitoba
- Master of Nursing – Nurse Practitioner Stream or equivalent educational preparation as approved by College of Registered Nurses of Manitoba (CRNM) required.
- Minimum 3 years' experience in community-based healthcare setting, working with youth and young adults and working in the areas of reproductive and STBBI health.
- Ability to perform practice-based research an asset
- Criminal Record Check required
- Child/Adult Abuse Record Check required
- Fluency in French preferred

Additional Requirements:

- A valid driver's license
- Availability to work some evening hours
