**Registered Nurse Authorized Prescriber (RNAP) - 1.0 EFT – Permanent**  
**\$45.04 - \$56.42 per hour**

A professional independent practitioner, fully accountable and responsible for their own clinical nursing practice, working within a multi-disciplinary team, works with individuals who access the community health primary care clinic and related health programming. The RN(AP) provides a continuum of primary care nursing services and supports, with a strong emphasis on community health theory, health promotion, disease prevention and treatment related to reproductive health and sexually transmitted blood borne infection in alignment with the Regulated Health Professionals Act and the standards and ethics of the College of Registered Nurses of Manitoba.

The Registered Nurse Authorized Prescriber is an advanced nursing role providing care in the area of sexually transmitted infections, blood borne pathogens and reproductive health and reports directly to the Program Manager and the general administrative direction of the Executive Director and is accountable to the communities we serve.

**I. KEY RESPONSIBILITIES**

**Primary Health Care**

- Provide primary health care services within the scope of the RNAP professional standards including: physical assessment, screening, triage, health education/counselling, history taking, managing lab requisitions, prescribing, referral and follow-up, and other clinical activities according to the Provincial Standards of Nursing Practice.
- Consult with medical staff and other providers when the person we serve's condition requires care beyond the scope of your practice (RNAP).
- Act as a member of an interdisciplinary team which assists with the development, analysis and implementation of policies and procedures to improve the delivery of primary health care services
- Ensure appropriate comprehensive treatment is provided, maintain complete and accurate charts and medical records, and participate in chart reviews and case conferences.
- Monitor and order medications, medical equipment and supplies, and equipment management systems for Primary Care programs.
- Order and receive diagnostic tests in the areas of reproductive health, sexually transmitted infections and blood borne pathogens
- Prescribe certain medications related to reproductive health, sexually transmitted infections and blood borne pathogens

**Health Education & Management**

- Provide the people we serve with education/resources related to health practices, illness prevention and navigation of the health care system to access health services.
- Complete intakes and coordinate comprehensive treatment plans.

**Clinical Nursing:**

- Provide safe, critical, competent, ethical, compassionate, and evidence-informed nursing care across the lifespan in response to community and individual needs.
- Complete and maintain the RNAP certification and notation to practice.
- Provides nursing assessment, monitoring and education to support community members in managing their conditions, preventing complications and improving their well-being.
- Practice from person-centred, harm reduction, social justice and Trauma informed/healing centred approaches.
- Provides clinical consultation to others on the healthcare team.
- Maintain and applies advanced technical/clinical knowledge and skills related to diabetes nursing educator practice and scope.

**Advocacy:**

- Support community members to voice their needs to achieve optimal health outcomes.
- Support community members who may be unable to advocate for themselves.
- Work to eliminate healthcare disparities in priority populations.
- Advocate for the use of Indigenous health knowledge and healing practices in collaboration with Indigenous healers and Elders consistent with the Calls to Action of the Truth and Reconciliation Commission of Canada.
- Advocate for the use of culturally safe approaches in all aspects of health promotion and treatment.
- Advocate for health equity approaches.

- Eligible for registration with the College of Registered Nurses of Manitoba
- Bachelor of Nursing Degree
- Completion of RN(AP) certified program and notation to prescribe from CRNM
- Minimum 4 years' nursing experience in community-based healthcare setting
- Knowledge of Adult Learning and Behaviour Change Principles
- Ability to perform practice based research an asset
- Criminal Record Check required
- Child and Adult Abuse Record Checks required
- Fluency in French preferred
